Memorandum of Understanding for co-operative activities related to “EXPO Milano 2015” between the Italian National Anti-Corruption Authority (A.N.AC.) and the Organisation for Economic Co-operation and Development (OECD)

Article 4, “Advisory Board”

Mr. Nicola Bonucci

Nicola Bonucci is the Director for Legal Affairs and the coordinator for accession. He joined the OECD in 1993 as a Legal Counselor, served as Deputy Director from 2000 until becoming Director in 2005. In his current position Mr. Bonucci represents the organisation in international fora and negotiate international agreements on its behalf he advises the Secretary-General and the OECD members on all matters of public international law and of the internal law of the Organisation.

Since 1997 Mr. Bonucci has been closely involved in the monitoring and follow-up of the OECD Anti-Bribery Convention and is a regular speaker in international conferences on this subject. Mr. Bonucci has been the Chair of the International Bar Association in 2011 and 2012 and he is currently the OECD Representative at the Anti Corruption Working Group of the G20. Mr Bonucci is a co-editor of the book *The OECD Convention on Bribery A Commentary* (2nd edition, published by Cambridge University Press, 2014)

Mr. Bonucci holds a DEA in Public International Law from the University of Paris X Nanterre, a DESS in International Administration from the University of Paris II-Assas, and a Master of International and Comparative Law from the University of Notre Dame.

Mr. Antonio Capobianco

Antonio Capobianco is a Senior Competition Expert with the OECD Competition Division at the Competition Division, Mr. Capobianco has coordinated a series of OECD projects and work streams, including the development of the 2009 Guidelines for Fighting Bid Rigging in Public Procurement and the related OECD Council Recommendation of 2012, the work on transparency and procedural fairness, on SOEs and competitive neutrality, and most recently he has been leading the work on international enforcement co-operation.

Prior to joining the OECD in 2007, Mr. Capobianco was a Counsel in the Competition Department of WilmerHale LLP, based in Brussels. He also spent three years with the Italian Competition Authority. Mr. Capobianco authored several articles on antitrust issues published on major international law

journals specialized in competition law and he co-authored textbooks on Italian and European competition law and economics. He regularly speaks at international conferences on antitrust and regulation issues. Mr. Capobianco graduated in law at the L.U.I.S.S. - Guido Carli in Rome and holds LL.M. degrees from the Law School of the New York University and from the Institute of European Studies of the Université Libre de Bruxelles.

Mr. Paulo Magina

Paulo Magina is currently the Head of the Public Procurement Unit at the OECD Public Sector Integrity Division.

With over 10 years' experience in the public sector, most recently he was a board member and the CFO of the Portuguese Central Government Shared Services Agency, in charge of finance, accounting, HR, IT and public procurement for the public administration. He was also the CEO of the National Public Procurement Agency, where he led the setting up of the central purchasing body and the e-procurement implementation. He also worked lately with the EBRD and UNCITRAL to advise policy and legal reforms, develop action plans and road maps for restructuring public procurement systems in the CIS region. Formerly he was deputy member of the cabinet of the secretary of state for transports in Portugal and also held managerial positions as CFO and Investment Director in the transportation, banking and private equity sectors, for more than 12 years. Paulo Magina holds a Business and Administration degree from Catolica Lisbon School of Business & Economics, and was an invited lecturer in post graduate and MBA programs in the same university lecturing Financial Strategy, Private Equity and Venture Capital. He held also several lectures and courses on PPP's.
