The representatives of NEIWA's members gathered in Rome have approved the following Declaration:

The Network of European Integrity and Whistleblowing Authorities (NEIWA), currently representing 34 Authorities, has been established in May 2019 to offer a platform for cooperation and exchange of knowledge and experiences in the area of integrity and whistleblowing.

NEIWA has considerably grown over the last years and strives to gather Public Authorities from EU Member States, EU-candidates and EFTA countries, who have a central and / or pivotal role in the field of whistleblowing (reports, investigation, protection, support, advice, prevention, education and or enforcement), with the EU Directive 2019/1937 on the protection of persons who report breaches of Union law as the common basis.

In bringing these authorities together, NEIWA aims to coordinate efforts towards the strengthening of the protection of reporting persons, through the exchange of knowledge and practices. The possibility to speak up, to safely report a breach of law or wrongdoing are essential conditions to advance work-related integrity and, by doing so, to protect the public interest. We also strive to uphold and promote recognized international standards for the protection of reporting persons and for integrity in work relations.

At the 8th General Assembly of NEIWA in Rome, the Network approved the inclusion of such goals and objectives in a constitution together with the principles that inspire the structure and workings of the Network. In addition, the Network elected a formal governance that includes the following:

With the establishment of a formal board and the validation of the Constitution, NEIWA takes an important step towards the future.

At the General Assembly in Rome, the members took stock of the current state of implementation of the EU Directive in the different member states and exchanged views on the national legislations approved so far and the processes followed to obtain such legislations. NEIWA members can not only learn from each other and from the different ways of implementation, but also from those experiences in view of the future implementation and putting in practise of the regulation. It means NEIWA will continue to work as a network on different topics, related to whistleblowing and integrity, to enhance our expertise and to share good practices within and outside the network.

NEIWA also ascertained that a number of EU member states have not yet completed the transposition of the EU Directive. NEIWA urges those countries to make haste with the transposition and implementation not only according to the letter but also to the spirit of the Directive.

NEIWA members call upon the legislators and all involved in the implementation process to:

- ensure that all reporting persons can benefit from effective legal, psychological and financial support when reporting;
- establish by law the prohibition of retaliation and ensure sufficient protection to reporting persons from retaliation, either direct or indirect by means of effective, proportionate and dissuasive penalties;
- make support and protection of whistleblowers more effective, and
- broaden the scope of the national law in the spirit of the Directive.

To make sure reporting persons receive the protection they need, NEIWA emphasizes the need to have one or more recognizable, centrally positioned authorities within each member state.

Those authorities should protect the confidentiality of their actions, be autonomous, work independently, and have sufficient resources and a well-trained staff to perform their important tasks. Whistleblowing authorities have to be able to make a decisive difference in the protection and support of whistleblowers.

As recently stated by the judgment of the European Court of Human Rights in the case Halet v. Luxembourg no. 21884/18 of 14 February 2023, NEIWA emphasizes the importance of the role of whistleblowers and their right to freedom of expression.

NEIWA is determined to give the topic of protecting people who speak up the importance it deserves, in the interest of all of us.

That is why we will continue to join forces with and bring together even more public authorities with a central or pivotal role in the field of whistleblowing, and when needed get ourselves heard and speak with one voice.

Finally, NEIWA, as a network of practitioners and experts in the area of integrity and whistleblowing, stands ready to collaborate as a key interlocutor with European and international public institutions and private organizations.
